#### SUPERINTENDENT'S REPORT

Dr. Steinhoff went over topics which were reviewed during last week's Study Session.

• 2022 – 2023 Proposed Final Budget was presented. Mr. Zebley gave a summary this evening indicating which includes a proposed mileage of 18.2593, Revenue estimated to be around \$67,471,000 and Expenditures at \$69,400,000. Dr. Steinhoff recommended approval of the proposed final budget this evening, which will allow them to fine tune the numbers once the PA State Budget is available.

Dr. Steinhoff noted additional items on the agenda for approval;

- Intrado Communication System, an Update to the District's messaging system. This offers a broader access with attendance; a web product and an app product.
- Recommended the hiring of Monica Quinn as Elementary Education Special Education Supervisor, replacing Amy Bell who is retiring in June.

Dr. Steinhoff highlighted some recent events within the District;

- There has been a lot of interest in the Dual Enrollment Program with Delaware County Community College;
- Northley Career Day was held on April 11<sup>th</sup>. There were 14 volunteer participants;
- The yearly mock crash was held at Sun Valley today. This had an impact on what can happen is you drink and drive.
- Recognized Ms. Cardwell, 1<sup>st</sup> grade teacher at Pennell, who is being honored by the Phillies at their 22nd annual All-Star Teacher Appreciation Night on Friday, May 6<sup>th</sup>.
- Recognized Ashley Marano, Pennell Paraprofessional who received the DCIU "Making a Difference Award". Ashley was nominated by interim Principal Danielle Murray for her hard work and dedication to the students she services;
- Recognized Wayne Lutteroty, Physical Education Teacher also from Pennell for receiving Teacher of the Year from Southeastern PA Shape (Society of Health and Physical Education);
- Earth Day Activities took place throughout the District last week;
- 18 students represented Penn-Delco in the 2022 DCIU Stem Competition. Coebourn Team 4 was awarded best blueprint in the county while Coebourn Team 3 won 3<sup>rd</sup> PLACE in the county for best overall project;
