THIS AGREEMENT ENTERED INTO THIS ____ DAY OF ____ 2020 BY AND BETWEEN THE BOARD OF SCHOOL DIRECTORS OF THE PENN-DELCO SCHOOL DISTRICT OF DELAWARE COUNTY, HEREINAFTER REFERRED TO AS THE BOARD, AND Kim McGinley, HEREINAFTER REFERRED TO AS THE CONTRACTOR, WITNESSETH:

1. For the consideration herein mentioned, the CONTRACTOR agrees to provide speech & language services for the **2020 – 2021 school year**.
2. The BOARD shall pay the CONTRACTOR the sum of **\$115.00** per hour for the provision of up to **17 hours per week** of speech & language services for a sum not to exceed **\$74,500.00**. If there is a change in this sum, a new contract shall be executed. CONTRACTOR shall be paid on or before the last day of the month for speech therapy services rendered on or before the first day of the previous month.
3. Speech therapy services shall be upon the terms and conditions herein and in accordance with the attached schedule. This contract shall terminate on **June 18, 2021**, unless terminated earlier for cause, or by mutual consent of the parties hereto in writing.
4. The BOARD and the CONTRACTOR agree that the CONTRACTOR is an independent entity and not the employee of the School District and is not entitled to any benefits provided by the BOARD to its employees.
5. Prior to the effective date of this contract, the BOARD shall have evidence that the CONTRACTOR must comply with Public School Code, which requires an **Act 34 Criminal History Record Information Report, Act 151 Child Abuse History Clearance, ACT 114 FBI Fingerprint Clearance, Act 168 Employment History Reviews and Act 126 Child Abuse Training and Mandated reporting** showing no adverse reports that would preclude such individual from working in direct contact with school age or preschool age children.
6. CONTRACTOR agrees to indemnify and hold harmless the Board of School Directors of the Penn-Delco School District and Penn-Delco School District from and against any and all actions, claims, and demands whatsoever that may result from the speech therapy services being provided hereunder or may result from the execution and delivery of this contract or from nonperformance thereof.
7. The CONTRACTOR agrees to furnish such documentation as is required by the BOARD or its designated representatives to substantiate the speech therapy services provided by CONTRACTOR pursuant to this contract and that the CONTRACTOR has complied with all federal and state laws regarding licensure that may be required to carry out the work to be performed under this agreement.
